The Arts, Music, and Instructional Materials (AMIM) Discretionary Block Grant allocates \$3,560,885,000 to LEAs, and VMCS shall receive \$146,637. The funded is to be used for five purposes,	

which may be briefly summarized as:

obtaining standards-aligned professional development and instructional materials for specified subject areas;
obtaining professional development and instructional materials for improving school climate;

3. developing diverse, culturally relevant and multilingual school library book collections;

operational costs, including retirement and health care cost increases; and
COVID-19-related costs necessary to keep pupils and staff safe and schools open for in-person instruction.

The governing board of the charter school receiving funds should discuss and approve a plan for the expenditure of funds received at a regularly scheduled public meeting. It is the intent of the Legislature that each school district, county office of education, or charter school expend any resources received consistent with their governing board- or body-approved plan.

File Attachments

The local plan for the AMIM Grant funds needs to be heard in a public meeting of the governing body of the charter school, before its adoption. The bill does not stipulate a date or timeframe when LEAs should present their plans to the appropriate local board. We will present the plan at this meeting, and then seek approval as part of the Action Items.

This year, the Anaheim Elementary School District (AESD) has asked to review the plan prior to us seeking approval by the VMCS Board. This was communicated to us on December 8, 2022. We provided AESD with our completed draft on the same day. it is uncertain if the draft of the CSSP will be reviewed by AESD prior to the December Board Meeting. However, it will be presented to the Board in its draft form and may be approved pending AESD's response. The final CSSP needs to be submitted by March 1, 2023.

With the CSSP, it is not a document that is shared broadly due to the sensitive nature of the content. Sharing it publicly could compromise the safety of our school community. Therefore, it will be shared with the Board separately under Executive Content.
